#### 1. Call to order

Meeting was called to order at 11:00 AM. Directors present were David Piepho and Norm Hattich. Director John LaTourrette was absent.

### 2. Approval of minutes

The Chair asked if there were any changes to the minutes or agenda. The Chair requested there be a motion to approve the minutes of the July 29, 2018 Johnsville Public Utility District (JPUD) meeting and to move item 3.3 to 3.1 on the agenda. Director Hattich made the motion to approve the minutes for July 29, 2018 minutes and switch the two items on the agenda in order for GLW to report first. Chair Piepho seconded the motion. ### 3. Public Comment

A homeowner asked the board what were the JPUD's water hookup to a new residence requirements and procedures. The Chair explained that the JPUD policies were under current review and revision by the Board. He referred the homeowner to the manager for information. Discussion included the need for a licensed contractor to do the work and that the water line be half inch. Also, current fire requirements need to be followed. The hookup would need to be inspected by JPUD staff as well. Any questions or concern can be brought to the water Board for consideration.

# 4. Reports from Graeagle Land and Water (GLW)

3.1 Barry Buchholtz reported that the plant work to be completed by George T. Hall would start at the end of October. Our water usage would be down and there will be less impact on customer service. Water could be offline one day at plant and one additional day at train. He may be able to run plant to compliancy. Barry was asked about future projects that need to be done so the board can include then in budget planning. He listed that three turbidity meters will need to be replaced (2200 each) and a chlorine analyzer (Barry will check on best price) will need replacing and grounded in case of a lightening strike. RESOLUTION, ADOPTION OF A THREE-YEAR RATE PLAN FOR THE CUSTOMERS OF THE JOHNSVILLE PUBLIC UTILITIES DISTRICT (JPUD).

WHEREAS, the mission of the Johnsville Public Utility District is to provide high quality, reliable, and safe water services for consumption and fire protection to all customers always. The Board of Directors has the responsibility to set and fund budgets that give the Johnsville Public Utility District the ability to meet both the long and short term needs of all customers always.

The Johnsville Public Utility District serves all customers by complying with federal and state laws. The Johnsville Public Utility District manages district resources and meetings in an open and responsible manner.

WHEREAS, the Board of Directors has concluded current service fees are inadequate to meet both the long and short term needs of all customers without an adjustment to the service fees paid to the Plumas County Treasurer for the operations of the Johnsville Public Utility District.

WHEREAS, to minimize the impact on customers the board has proposed a three-rate plan.

WHEREAS, the board authorizes the Plumas County Treasurer the authority to bill the customers of the Johnsville Public District annually the amounts indicated on the attached schedule commencing FY 2018.

The following Johnsville Public Utilities District Officers holding the title(s) specified hereinbelow or their successors in office are each hereby authorized to order the deposit of monies to the Plumas County Treasury on behalf of the Johnsville Public Utilities District. The Johnsville Public Utilities District may execute and deliver all documents necessary or advisable to effectuate the purposes of this resolution and the transactions contemplated hereby:
