## 2.2.2 Review USDA Loan and Grant Application

Director LaTourrette noted our loan application with USDA has been completed. USDA stipulated a resolution be passed by the JPUD authorizing the district to move forward with a loan application for\$483,000 with an underlying grant of \$350,000 for the Johnsville Public Utility District Tank & Liquid Chlorination Project. This resolution will be known as "Resolution 24-09 Authorizing and Approving a Loan Agreement with United States of America, Acting Through Rural Utility Services, United States Department of Agriculture and Authorizing the Vice Chair of The Board to Execute and Deliver the Loan Agreement." The resolution will be known as Resolution 24-09 which conforms with the JPUD's numbering convention as opposed to "District Resolution Number 2024".
